TERMS AND CONDITIONS OF ENTRY

1. **Terms & Conditions:** These Terms & Conditions of Entry include information on how to enter and prizes. Participation in the 'Easter Bunny Bonanza' Promotion ('Promotion') is deemed acceptance of these Terms & Conditions of Entry.
2. **Participation venue:** the Promotion is only available at the Lakes Entrance Bowls Club, 35 Rowe Street, Lakes Entrance, 3909, Victoria ('Venue'). The Promoter is the Lakes Entrance Bowls Club Inc. ('Club').
3. **Eligibility:** Entry is open to all financial members of the Club who are over 18 years of age. Entry is not open to employees of the Club who are directly involved in and/or associated with the conduct of the Promotion, nor their immediate families including spouses, parents, siblings and children of those employees.
4. **How to enter:**
 - a. It is not a precondition of entry to the Promotion that you play a gaming machine, or participate in a loyalty scheme that requires expenditure on gaming machine play or agree to receive gaming machine advertising.
 - b. To qualify to enter the Promotion, members earn points* by presenting their Membership Card when making any purchases during 9am Thursday 1st March 2018 and 6.45pm on Thursday 29th March 2018.
 - c. The Member must then swipe their Membership Card at the Club's Rewards Kiosk on Thursday 29th March 2018 between 9.00am and 6.45pm to receive 1 ticket per 50 points earned, and deposit the ticket into the ticket barrel by 7.00pm on Thursday 29th March 2018. (The tickets will have the member's name and membership number printed on them.)
 - d. All tickets deposited in the ticket barrel by 7.00pm on Thursday 29th March 2018 will be included in the Prize Draw and be eligible to win a Prize.
5. **Prize Draw:** The Prize Draw will be conducted at the Club and commence at 7.00pm on Thursday 29th March 2018. Tickets will be randomly drawn from the ticket barrel, the winner's name will be announced. Members must be present at the Draw and will have one minute to claim their Prize. If the Prize is unclaimed after one minute another ticket will be drawn. The Draw will continue in this manner until all prizes have been claimed.
6. **Prizes:** 28 Chocolate Easter Egg Hampers. Total prize RRP \$1,650
 - a. The 1st ticket drawn will win the 1st Prize, Extra Large Cadbury Easter Egg Hamper RRP \$200
 - b. The 2nd and 3rd tickets drawn will each win their 2nd and 3rd Prizes respectively, Large Cadbury Easter Egg Hamper, RRP \$125
 - c. The 3rd to 18th tickets drawn will each win their 3rd to 18th Prizes respectively, Medium Cadbury Easter Egg Hamper, RRP \$60
 - d. The 19th to 28th tickets drawn will each win their 19th to 28th Prizes respectively, Small Cadbury Easter Egg Hamper, RRP \$30
 - e. A maximum of 2 Prizes will be awarded to any one Member of the Club and only Members may claim their prize.
7. **Delivery:** The Prizes will be available from the Venue at the conclusion of the Prize Draw.
8. **Valid Entries:** Only valid tickets issued by the Club will be accepted into the Prize Draw. Tickets are void if stolen, forged, mutilated, photocopied or tampered with in any way.
9. **No waiver:** Failure by the Club to enforce any of its rights at any stage does not constitute a waiver of those rights.

10. *Club's decision is final*: If there is a dispute concerning the conduct of the Promotion, the Prize Draw of the awarding of Prizes, the Club's decision will be final and no correspondence will be entered into.
11. *Cancellation/delay/modification*: If, for any reason whatsoever, any part of the Promotion, the Prize Draw or the awarding of Prizes is not capable of running as planned, the Club reserves the right to cancel, terminate, delay, relocate, modify or suspend any or all of the elements of the Promotion, the Prize Draw or the awarding of Prizes, subject to the written directions from any regulatory authority.
12. *Privacy*: Personal information collected for the Promotion will not be used for any purpose other than for the conduct of the Promotion. All tickets become the property of the Club. The Club complies with the Australian Privacy Principles. The gain access to your personal information held by the Club, phone or write to the Club at the Venue.
13. *Publicity*: Players consent to the Club using their name, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of advertising the Promotion, and promoting any of the Club's products or services.
14. *Limitation of Liability*: Except for any liability that cannot be excluded by law, the Club, its employees and agents, will not be liable for any loss, damage, or personal injury whatsoever (including negligence), which is suffered, incurred or sustained in any way in connection with the Promotion.
15. *Governing law*: The law of the state of Victoria govern the Promotion.

* Points are earned by making purchases at the Club. Food and Beverage points are earned at a rate of 2 points per \$1 spent, gaming points are earned at a rate of 1 point per \$10 gaming turnover.
